- TEAM RESTRICTION:** A team will consist of one man and one woman.
- FORMAT:** Entrants will bowl 6 scotch games moving one pair to the right after each game. Winners will be decided after at the end of the 6th game.
- AVERAGES:** Entrants will use their highest USBC certified adult league average based on a minimum 21 games or more for the 2019-2020 season. If no last season winter average, use the highest certified league average based on 21 games as of February 14, 2021.
- HANDICAP:** To the actual scores bowled in each series, shall be added a handicap of 100% of the difference between the teams average and 220.
- ENTRY FEE:** The entry fee will be \$25.00 per person. Prize fund \$16.00, lineage fee \$7.50, expense fee \$1.50. Make all checks payable to Lynchburg Area USBC. There will be a service charge of \$30.00 for all returned checks. Optional scratch event entry fee will be \$10.00 per person. Prize fund \$9.00, expense fee \$1.00.
- ORDER OF BOWLING:** Bowlers will alternate shots. Bowler 1 throws a ball Bowler 2 throws the next ball. This will continue till the end of game 6.
- PARTICIPATION:** The LAUSBC will be hosting this tournament, but all bowlers are welcome to enter. If you are not a LAUSBC member please bring your sanction card.
- BOWLING CONDITIONS:** The tournament shall be bowled on a house pattern and will be posted at the sign in table.
- RULE REGARDING CONDUCT:** Each participant is expected to exhibit good sportsmanship while participating in this tournament. The excessive use of foul language or improper conduct will result in the bowler being issued one (1) warning. Additional violations will result in the immediate disqualification of the bowler from the event.
