1. **FORMAT:** Entrants will bowl 6 baker games bowling on one lane at a time and moving one lane to the right. The top 4 teams will advance to a eliminator final.
2. **AVERAGES:** Entrants will use their highest USBC certified adult league average based on a minimum 21 games or more for the 2020-2021 season. If no 2020-2021 season average use highest average based on 21 games or more for the 2019-2020. If no average, use the highest certified league average based on 21 games as of October 16, 2021.
3. **AVERAGE CONVERSION:** Standard averages will be converted to Challenge for this tournament.
4. **HANDICAP:** To the actual scores bowled in each series, shall be added a handicap of 85% of the difference between the teams average and 210.
5. **TEAM CAP:** The team cap shall be a combined average of 420.
6. **ENTRY FEE:** The entry fee will \$40.00 per person. Prize fund \$30.00, lineage fee \$6.50, and a \$3.50 expense fee. Make all checks payable to Lynchburg Area USBC. There will be a service charge of \$30.00 for all returned checks. Optional scratch event entry fee will be \$10.00 per person. Prize fund \$9.00, expense fee \$1.00.
7. **ORDER OF BOWLING:** Bakers team members bowl alternate frames. Bowler A bowls frames 1,3,5,7,9. Bowler B bowls frames 2,4,6,8,10. Order of bowling may only be changed between games.
8. **BOWLING CONDITIONS:** The tournament shall be bowled on a challenge pattern and will be posted at the sign in table.
9. **RULE REGARDING CONDUCT:** Each participant is expected to exhibit good sportsmanship while participating in this tournament. The excessive use of foul language or improper conduct will result in the bowler being issued one (1) warning. Additional violations will result in the immediate disqualification of the bowler from the event.
